CLARIFICATION ON ESSENTIAL QUALIFICATION & REJECTION OF APPLICATIONS PERTAINING TO ADVT.NO.1/2015-NER

No.SSCG-A-12024/44/2015-Rectt.,Dtd.10/09/2015: With reference to this office Advt.No.1/2015-NER: Cat.No.1B/NER: Technical Superintendent (Weaving), 2B/NER: Technical Superintendent (Processing), and 3B/NER: Textile Designer, the Tentative Reject Lists of candidates was uploaded in the website and several representations have been received from aspiring candidates duly supported by Office of the Principal, Assam Textile Institute & also by Director of Technical Education, Assam, Guwahati. The matter was examined in consultation with the User department and it is clarified that in the existing Recruitment Rules to these posts, there is no provision of any equivalent EQ for filling the post by Direct recruitment. Hence, in absence of any provisions in statutory rules for recruitment to the post of Technical Superintendent (Weaving) in Weavers' Service Centre, "Diploma in Textile Technology" cannot be treated as equivalent to Diploma in Handloom Technology or Handloom & Textile Technology. Same provisions exist in Recruitment Rules for the post of Technical Superintendent (Processing) and Textile Designer.

Consequent upon the above clarifications, those candidates with only Diploma in Textile Technology are not eligible for the post of Technical Superintendent (Weaving) & Technical Superintendent (Processing) and as such, the Rejection of their candidature is final. Similarly, candidates having Bachelor's Degree in Fine Art but not with Textile Design such as Bachelor of Fine Art(H) in History of Art/ Art History etc. are not eligible as per the Recruitment Rules pertaining to Textile Design. Moreover, candidates having Diploma in Textile Design but having less than three years experience are also not eligible as per EQ(ii) of the Recruitment Rules for the post of Textile Design. Hence, rejection of the application of such candidates is final and no further communication need be issued or entertained on the matter.
