2. All candidates, who have appeared in Skill Test, are advised to submit their Option-cum-Preference for Post(s)/Organization(s) for Stenographer Gr 'C' & 'D' Examination, 2022 through their respective 'CANDIDATE LOGIN' on the website of SSC(Headquarters) *i.e* https://ssc.nic.in wherein a tab for submission of Option-cum-Preference for Post(s)/Organization(s) will be activated which will remain active during the period from 19.06.2023 to 25.06.2023.

3. Candidates may please also note that Option-cum-Preference can be revised only during the aforesaid period and the Option-cum-Preference last submitted by the candidate will be treated as final. **Candidates who fail to exercise their Option-cum-Preference during the aforesaid period, shall not be given any further opportunity for submission of their Option-cum-Preference and such candidates will not be considered for inclusion in the final merit list/final selection.** Therefore, the candidates who have appeared in Skill test are required to mandatorily exercise their Option-cum-Preference for consideration of their candidature in the final merit list/final selection in Stenographer Gr 'C' & 'D' Examination,2022.

4. PwBD candidates must ensure that they give preference(s) for only those post(s) which are identified as suitable for their disabilities. Allocation of posts will be made as per the provisions of the Notice of Examination on the basis of 'merit-cum-preference of posts'. The candidature of a PwBD candidate will get cancelled by the User Organization concerned if he/she gets selected for a post that is not identified as suitable for his/her disabilities.
