In this regard, it is further intimated that as per decision of the Commission (indicated in the Para 14 of the Notice) while making allocation in the Review Medical Examination result declared on 30.01.2014, only those candidates have been considered for allocation who have obtained marks equal to or more than the lowest marks obtained by the candidates already selected in SL /RL/ RL-2 for each CAPF and each category. The candidates who were not selected in SL/RL due to Blank/invalid/ limited options were also considered after substituting their preference as ABCDEF i.e. the default preference order in the Notice.

Hence, even though you were medically and physically fit, you were not selected due to low merit.

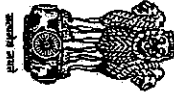

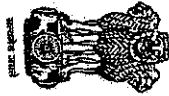
